The Participant refer to the undersigned person, as an athlete/gymnast, official administrator, coach, volunteer, parent and/or spectator that participates in any of the Activities at the Club or is present at the Club.

This Waiver and Release of Liability shall remain valid for the entire calendar year in which it is executed and will remain in force until it is expressly revoked by written notice from the Participant to the Club or renewed after a Year by the Club.

GENERAL INDEMNITY

Gymnasts (their parents or guardians on their behalf) are required to consent to the following accepting the risk and responsibility of their minor by part taking in gymnastics activities.

The Participant hereby fully and forever releases, discharges, holds harmless and agrees to indemnify Club and their Affiliated Persons and Entities from and against any and all, claims whatsoever, which may be brought against them by the Participant or any third party or other person claiming on my behalf, arising out of injury (including, for example, but not by way of limitation, injuries to bones, joints, muscles and internal organs), illness, damage, loss, mishap, accident or any other occurrence to me or my property as a result of attending Activities, including travelling to and from the Club. The Participant is aware of the risks of participating in gymnastics Activities and as such, and hereby voluntarily and willingly assume full and complete responsibility for all losses and damages, including injury, illness, and death, that he/she, or minor, may suffer. Parents/guardians (where applicable) also voluntarily and willingly assume full and complete responsibility for all losses and damages, including injury, illness, and death, that they may suffer.

The Participant undertakes to pay tuition fees in advance and give one calendar month's written notice of termination of classes. Members who do not give notice in writing will be charged for the full calendar month's fee. Fees are payable each term for 12 months to be paid at the beginning of the term. Participant undertakes to pay the annual registration fees as determined from time to time by Club management.
